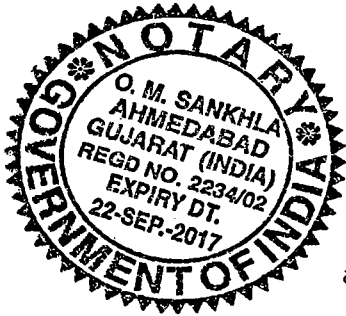

(3) Area of Operation: Entire Gujarat State.

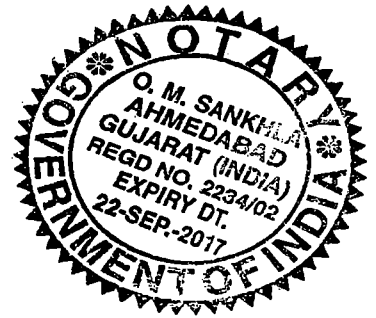
(4) Objects: The objects of the Trust will be  
as follows:

(1) This trust will mainly function for children  
welfare, social prosperity and women  
welfare.

(2) Will undertake activities in education field  
for study, training to students.

(3) This trust will start and maintain library,  
reading rooms, tuition classes etc.

- (4) Will establish and maintain Balwadies, Aanganwadis, primary, middlary and higher secondary schools, colleges, Ashramshalas, boardings, hostels, education centers for aged, technical training classes, computer classes etc.
- (5) This trust will distribute free books, notebooks and uniforms among poor students, will provide and cause to be provided scholarships, will motivate bright boys and girls students, will distribute shields and extend help.
- (6) With a view to provide employment to non-employments, this trust will establish and maintain professional, employment basis taining centers, type, shorthand, sewing, knitting, screen printing, book-binding, beauty parlours, wooly carpets, computer and electronics training classes.



- (7) The trust will take on hand the projects pertaining to communal harmony, oppose against child labour activities, outrages towards women, dowry system and other social bad customs. Will provide tricycles to handicaps, will publish news papers, magazines and will organize tours.
- (8) Will organize group marriage: Will organize concourse of marriageable boys and girls, prohibition, programs for planting trees, gatherings etc.
- (9) Will provide all type of relief in the event of natural calamity, flood problem, drought, excessive rain, earthquake, riots and violence to provide relief of food, clothes, financial and all other possible aids to the victims of such calamities.
- (10) To provide free medical aid to the needy people, like eye camp, blood donation, workshops, diagnosis camps and to arrange

clinics, hospitals, and to establish, run and maintain them.

(11) Will organize camps for getting rid from the addiction from intoxicant drinks, drugs etc. Will celebrate national festivals and will arrange cultural programmes.

(12) Will provide food, fruits, medicines to poor and needy patients and also will arrange to provide blood, medicines at a fair price.

(13) To arrange workshop for ayurved diagnosis camps and to provide ayurved medicines at a fair price and to extend help.

(14) The trust will run and maintain library, book houses, sports clubs and other training classes etc., like music classes, drawing classes, film show, drawing competition, essay writing competition, debate competition, street drama etc.

- (15) Will take on hand all activities and activities related all functions for development and social welfare field run by gram vikas agencies.
- (16) Will take on hand all activities related to development and whole activities of Khadi Gramodyog Board and Khadi Gramodyog Commission and cottage industries fields like sale, education, canvassing and research in the above fields.
- (17) Will establish, run and maintain, but within the limits of this trust, the gaushala (cow shelters), grass depot, cattle food and to arrange cattle camps for dumb animals like cows etc.
